CORPORATION OF THE TOWN OF HAWKESBURY

By-law N° 46-2015

**A By-law to appoint Benjamin Dicaire
By-law Enforcement Officer,
Property Standards Officer and
Municipal Weed Inspector
for the Corporation of the Town of Hawkesbury**

WHEREAS Subsections 15 (1) and (2) of the *Police Services Act*, R.S.O. 1990, c. P.15, as amended, prescribes that a municipal council may appoint persons to enforce the by-laws of the municipality and that such municipal by-law enforcement officers are peace officers for the purpose of enforcing municipal by-laws;

AND WHEREAS the *Building Code Act*, S.O. 1992, c. 23, s. 15.1, as amended, prescribes standards for the maintenance and occupancy of property within the Corporation and for prohibiting the occupancy or use of such property that does not conform with these standards;

AND WHEREAS By-law N° 50-2001 which was adopted on July 10, 2001 to prescribe standards maintenance and occupancy of property within the Corporation also provides for administering and enforcing of same by Property Standards Officers;

AND WHEREAS the *Weed Control Act*, R.S.O. 1990, c. W.5, as amended, prescribes that municipalities may by by-law appoint one or more persons as Municipal Weed Inspectors;

AND WHEREAS it is deemed necessary and desirable to appoint a By-law Enforcement Officer, Property Standards Officer and Municipal Weed Inspector for the Corporation of the Town of Hawkesbury.

NOW THEREFORE, the Council of the Corporation of the Town of Hawkesbury enacts as follows:

1. **THAT** Benjamin Dicaire be and is hereby appointed By-law Enforcement Officer, Property Standards Officer and Municipal Weed Inspector for the Corporation of the Town of Hawkesbury.
2. **THAT** the duties of the By-law Enforcement Officer shall be to enforce municipal by-laws.
3. **THAT** the duties of the Property Standards Officer to whom is hereby assigned and entrusted the responsibility shall be to administer and enforce By-law N° 50-2001 and any by-law amending the same hereafter enacted.

4. **THAT** the duties of Municipal Weed Inspector shall be to enforce the *Weed Control Act* and municipal By-law N° 2387 as amended and shall carry out his duties in co-operation with the area weed inspectors and the area weed inspectors may, when they consider it necessary, exercise all the powers of an inspector under the *Weed Control Act* within the boundary of the Corporation of the Town of Hawkesbury.
5. **THAT** By-law N° 45-2015 appointing Steve Loiselle be repealed.
6. **THAT** this By-law shall come into force and take effect upon its adoption.
